- The total number of stores as of September 30, 2023 stood at 103. The Company has opened 3 (three) new stores and closed 5 (five) store during the Q2 of Financial Year 2023-24 (July 2023 to September 2023). Total Retail area as on September 30, 2023 is ~11 lakh sq.ft.
