- The total number of stores as of December 31, 2023 stood at 107. The Company has opened 7 (seven) new stores and closed 3 (three) stores during the Q3 of Financial Year 2023-24 (October 2023 to December 2023). Total Retail area as on December 31, 2023 was ~11.40 lakh sq.ft. (~10.59 lakh sq.ft. as on December 31, 2022).
